Description and Extent of Change:

CUSTOMERS RECEIVING PRODUCTS WITH THE STANDARD BROADCOM LABEL (INN_GEN1 or LS0058):

- Be ready to receive inner packs/boxes where the standard Broadcom label (mother label) has a "REF:" text, instead of "COO:" text, with a 2-digit barcode (with plain text value removed).
 Refer to the images below for illustration.
- Shipments can contain labels with either format ("COO:" versus "REF:").
- If customer needs to register in their system for the COO of the material, they can do so by scanning either the "COO:" or the "REF:" barcode.
