#### **Description Of Change:**

1.ADI is adding ASE, Korea (AEK) as an alternate assembly site for select LFCSP products being manufactured at Amkor, Philippines (AP3). 2. ADI has qualified ASE's standard bill of materials in sawn LFCSP 4x4x0.85mm package.
