




Fig. 1 - Typical Output Characteristics




Fig. 2 - Typical Transfer Characteristics




Fig. 3 - Switching Loss vs. I_{C}




Fig. 4 - Switching Loss vs. R_G




Fig. 5 - Gate Charge Characteristics




Fig. 6 - Typical Capacitance vs. Collector-Emitter-Voltage




Fig. 7 - Diode Forward Characteristics




Fig. 9 - Typical Forward Characteristics (Diode)




Fig. 8 - Typical Switching Times vs. Rq





Fig. 10 - Transient Thermal Impedance
